If a battery storage project — Hecate's Humidor — was to be approved in a location such as Acton, where it would be amongst residents in a Very High Fire Hazard Area, you are placing a tremendous amount of pressure on our LA County Fire Department to thwart a potential disaster.

Until a battery technology emerges with a much lower fire, overheating, thermal runaway, explosion and toxicity risk that can be utilized in these utility scale applications, there needs to be extreme scrutiny given to the safe siting of these facilities using large capacity lithium-ion batteries.

"Distribution" or "transmission," they all would carry the same potential risk to life and property. The difference in risk would be determined only by their siting.
